1.0 Introduction

 endeavour to adapt our environment to suit the needs of the child. All children are entitled to
 full access to a broad and balanced curriculum, differentiated to meet their individual needs.
 We will use our best endeavours to appropriately integrate children with SEND in mainstream
 school activities. No child will be treated less favourably than other pupils.
- We are committed to providing an accessible environment which caters for the needs of pupils
 with a disability. We conduct an accessibility audit every 3 years and modify it as necessary
 during this period. From this we publish an Accessibility Plan, reviewed annually, that also
 covers a 3 year period. This plan includes:
